- 4. Closing Deadline Strictness:** Bids received after the submission deadline date and time will be rejected automatically.
- 5. Tax Eligibility & ATL Status:** Only active taxpayers listed on FBR's Active Taxpayers List (ATL) with a valid NTN are eligible to participate. Applicable statutory taxes will be withheld at source as per Government rules.
